TOURIST VISA APPLICATIONS

THE FOLLOWING DOCUMENTS ARE TO BE PRESENTED WHEN SUBMITTING VISA APPLICATIONS:

1. Visa application must be submitted in duplicate and signed by applicant. Signature of the application should correspond to the signing in the travel document.
2. Two passport photos
3. At least 6 months valid Passport/Certificate of Identity or other acceptable travel documents.
4. A leave of absence letter from your employer
5. Personal financial documents:
 - Inland revenue receipt
 - Property tax/rate demands
 - Current account statements
 - Bank books and/or fixed deposit certificates
6. Letter of guarantee from your reference if the proposed visiting is sponsored by reference.
7. The applicant is required to conduct an interview.
8. Visa Fee is HK\$280.- Fax charges: HK\$150- i.e. a total of HK\$430.-and should be paid in CASH
9. All visa applications will be sent to the Passport, Immigration and Citizenship Agency (PICA) in Jamaica for approval and consideration. Visa will be issued accordingly within three working days once the approval is received from PICA.

Please be advised that the submission of fraudulent documents in supporting of the visa application may permanently bar from entry into Jamaica.

Also it is advisable to submit the application earlier as it will take some time to seek the approval from Jamaica.

BUSINESS/EMPLOYMENT VISA APPLICATIONS

THE FOLLOWING DOCUMENTS ARE TO BE PRESENTED WHEN SUBMITTING VISA APPLICATIONS:

1. Visa application must be submitted in duplicate and signed by the applicant. Signature of the application should correspond to the signing in the travel document.
2. Two passport photos
3. At least 6 months valid Passport/Certificate of Identity or other acceptable travel documents.
4. Letter of guarantee from the employer who is responsible the expenses of the trip with the endorsement from a banker in the effect that the guarantor is financially capable.
5. A certified copy of the original business registration
6. Evidence of business contacts or correspondence verifying your purpose in making the proposed trip
7. For employment visa applicant, not necessary to submit item 4-6, and must submit the Police Certificate and Work Permit.
8. Applicant is required to conduct an interview.
9. Visa Fee is HK\$280.- Fax charges: HK\$150- i.e. a total of HK\$430.-and should be paid in CASH
10. All visa applications will be sent to the Passport, Immigration and Citizenship Agency (PICA) in Jamaica for approval and consideration. Visa will be issued accordingly within three working days once the approval is received from the PICA.
