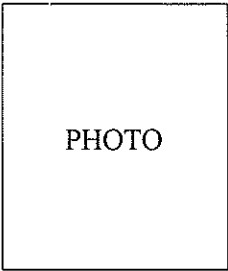

**ATTENTION TO TOURIST:**

- Authorized for stay in hotels, according to amount of money declared to Immigration authorities on arrival.
- The passenger must have a RETURN TICKET to show to the Immigration authorities.
- In no case should the holder of a Tourist Card engage himself in any other activity but TOURISM.
- Cuban authorities may invalidate the Tourist Card and deny the entrance to those declared as undesirable persons. In such case, the person concerned must cover by the expenditure for going back plus any other expense caused by his behavior.

## **Special Facilities for Tourist Purposes**

Those persons intending to travel to Cuba with tourist purposes can apply for a tourist card which may be granted in 5 working days.

To obtain a tourist card, equivalent to tourist visa, you must fill in the application form with all the information.

The tourist card can be used only within the term of 180 days after being granted. The length of stay must be fixed according to the financial means for your own support to be declared upon your arrival in the Cuban Airport.

Cuban Authorities may deny the entrance to Cuban territory to those persons who do not possess a return ticket to go out of the country to any place in the world. In this case, the person concerned must cover by the expenses for going back or any other expenditure being caused as result of it.

### **Please read the undermentioned noted carefully before you start to fill in the form;**

- Tourist card will be issued on base of information given by applicant and must match that information given in the passport.
- Any change requested by the applicant after having received the issued card may be only possible by paying the same fee for a new one. Any mistake in the issued card as result of incorrect information or unclear hand writing in the form will be considered the applicant's own responsibility and consequently he must pay again for a new card if he wants to make the correction.
- To avoid delays and misunderstanding, make sure that all questions are answered fully and correctly.
- The tourist card you receive will have two sheets, one will be taken by the Cuban immigration authorities at arrival and the other at departure.
